### EXECUTIVE ORDER NO. CGBR 29 Series of 2022

EXECUTIVE ORDER RE CONSTITUTING THE LOCAL ZONING REVIEW COMMITTEE (LZRC) AS A FUNCTIONAL COMMITTEE UNDER THE LEGAZPI CITY PLANNING AND DEVELOPMENT COUNCIL

WHEREAS, Local Government Code of 1991, mandates Local Government Units, in conformity with existing laws, to continue to prepare their respective comprehensive land use plans implemented through Zoning Ordinances, which shall be the primary and dominant bases for the future use of land resources:

WHEREAS, the implementation of the Comprehensive Land Use plan would require the enactment of regulatory measures to translate the planning goals and objectives into reality; and the Zoning Ordinance is one such regulatory measure and which, is the implementing tool of the said plan;

WHEREAS, per City Zoning Ordinance, specifically, Article X - Administration and Enforcement, Sections 15 and 17, the Local Zoning Review Committee (LZRC), is tasked to review the Zoning Ordinance considering the Comprehensive Land Use Plan and the Master Development Plan, as need arises, based on the following reasons/situations: Changes in the local development plans, introduction of projects of national significance, petition for rezoning and other reasons which are appropriate for consideration:

### Section 1. Functions and Responsibilities of the LZRC

The LZRC as a quasi-judicial body, shall perform the following functions and responsibilities:

- 1. Review the Zoning Ordinance for the following purposes:
  - a. Determine the amendments or revisions necessary in the Zoning Ordinance because of changes that have been introduced in the Comprehensive Land Use Plan (CLUP).
  - b. Determine changes to be introduced in the CLUP in the light of permits given, and exceptions and variances granted.
  - Identify provisions of the Ordinance difficult to enforce or are unworkable.
  - d. Recommend to the Sanggunian Panlungsod, through the LCPDC (do the City Planning and Development Office), necessary legislative amendments, that need changes as a result of the review.
  - e. Provide information to the City-SP and LCPDC that would be useful in the exercise of its functions.
