EXECUTIVE ORDER NO. <u>CGBR</u> 33 Series of 2022

EXECUTIVE ORDER RECONSTITUTING THE LOCAL HEALTH BOARD OF THE CITY OF LEGAZPI, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES.

WHEREAS, Article 185 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act 7160) mandates the creation of the Local Health Board (LHB);

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and there shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children;

WHEREAS, the recent local elections require reconstitution of the LHB due to the end of term of office of former LHB members; and

WHEREAS, based on the above premises, the City Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the LHB;

NOW, THEREFORE, I, CARMEN GERALDINE B. ROSAL, City Mayor of Legazpi City, by virtue of the powers vested in me by the law, do hereby order the reconstitution of the LHB of the City of Legazpi, with the following stipulations:

Section 1. Composition

The Local Health Board of the City of Legazpi shall be composed of the following:

Section 2. Duties and Functions of the LHB

The LHB shall perform the following functions:

- a) Propose to the Sanggunian Panlungsod of Legazpi, in accordance with the standards and criteria set by DOH, annual budgetary allocations for the operation and maintenance of health facilities and services within the province, city, or municipality, as the case may be;
- b) Serve as an advisory committee to the Sanggunian Panlungsod of Legazpi on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and
- c) Create committees which shall advise, local health agencies on matters such as, but not limited to, technical and administrative standards of DOH, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions.

Section 3. Meetings and Quorum

- a) The LHB shall meet at least once a month or as often as may be necessary.
- b) A majority of the members of the board shall constitute a quorum, but the chairperson or the vice chairperson must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of a majority of the members shall be necessary to approve such proposals.

Section 4. Budget

The local health board budget shall give priority to the following:

- a) Universal Health Program;
- b) Provision of funds in addressing the identified gaps on health care services for:
 - b.1 During disaster response forces:
 - b.2 Improvement/upgrading of health care services;
 - b.3 Procurement of laboratory equipment and supplies; and
 - b.4 Procurement of medical equipment and supplies.
- Improvement of City response Capacity by strengthening the Incident Command System and task Forces; and
- d) Maintenance/Upgrading of the Legazpi City Hospital.

Section 5. Compensation and Remuneration

The co-chairpersons and members of the [provincial/city/municipal] health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the LHB, subject to existing accounting and auditing rules and regulations.

Section 6. Repealing Clause

All Executive Orders or issuances inconsistent with the provisions of this Executive Order are hereby repealed, superseded or modified accordingly

Section 7. Effectivity

This Executive Order shall take effect immediately.
