KNOW ALL MEN BY THESE PRESENTS:

This EXTENSION OF CONTRACT FOR PROTECTIVE AND SECURITY SERVICE is made and executed by and between:

THE CITY GOVERNMENT OF LEGAZPI a local government entity duly registered, organized and existing under and by virtue of laws of the Republic of the Philippines with office at City Hall Compound, Legazpi City represented herein by its City Mayor, HON. CARMEN GERALDINE B. ROSAL and hereinafter referred to as "CLIENT";

HI-TONE SECURITY AGENCY, INC., a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at 2nd Floor De Fedbac Bldg., Peñaranda Ext., Bonot, Legazpi City represented herein by its President, MS. DONNA S. CO, hereinafter referred to as the "AGENCY"

WHEREAS, the **AGENCY** is a duly licensed and bonded security agency operating under the provisions of Republic Act No. 5487, as amended.

WHEREAS, in accordance with Republic Act No. 9184 and its implementing Rules and Regulations, the Bids and Awards Committee of Legazpi City conducted competitive bidding for security.

WHEREAS, the **CLIENT** found the **AGENCY's** bid proposal to be the lowest responsive bid and accordingly, the BAC recommended for the award of the contract to the **AGENCY**;

WHEREAS, pursuant to the *Notice of Award (NOA)* dated December 29, 2022 the Contract was awarded to the **AGENCY** who signified its "Conforme" in the same NOA;

WHEREAS, per the contract originally entered into by the parties, the **AGENCY** shall be rendering Security Services to the client from January 1, 2023 to December 31, 2023.

WHEREAS, the BAC has thus commenced the procurement of Security Services for the year 2024 on November 28, 2023. However, all the bidders were post-disqualified;


WHEREAS, since there is no longer enough time to complete the bidding process and award a new contract to a qualified bidder prior to the expiration of the original contract between the AGENCY and the CLIENT, the parties hereby agree to **extend their original contract from January 1, 2024 to March 31, 2024 pursuant to GPPB Resolution No. 06-2022** and under such terms and conditions:

1. The terms and conditions in the original contract between the AGENCY and the CLIENT are hereby adopted, except for the price consideration which has changed due to the passage of Wage Order No. RBV-21 which increased the minimum wage to P 395.00 per day as of December 1, 2023. Hence, the total consideration under this contract is:

DAY-SHIFT GUARDS	P 20, 595.09 per month	P 31, 675.96 per month
NIGHT-SHIFT GUARDS	P 22, 302.83 per month	P 34, 272.35 per month

2. This contract shall take effect on January 1, 2024 and shall automatically end on March 31, 2024.
3. If any portion of this extension contract is inconsistent with the original contract, the latter prevails.
4. If any portion of this contract is found inconsistent with existing laws, rules and regulations, those not affected thereby shall remain as valid and binding between the parties.


