- j) Establish and maintain partnerships with NEDA, PPP Center, DTI, NCC, DOST, DOF, BOC, SEC, BLGF, NGOs/CSOs, academe, and other stakeholders in the implementation of PPAs that will promote business-friendliness and competitiveness of the City;
- k) Represent the City in trade and investment meetings, conferences, and other similar activities in both domestic and foreign venues; and
- I) Prepare and disseminate investment promotion collaterals.
